Terms and Conditions

Please ensure you have read and understood these terms and conditions before placing your order.

Payment

No orders will be dispatched until payment has been received in full. For commissions a 50% deposit is required upon ordering. Work will not begin until this deposit has been paid; the date this is received and confirmed is the 'order confirmation date'. This secures your place in the list of work in progress. A photograph of your finished commission can be sent by email for your approval if you wish to. Full payment is due on completion and approval.

Cancellation

If you wish to cancel your commission please notify Gary as soon as possible. Commissions cancelled less than 14 days after your order confirmation date will incur a cancellation charge of 10% of the total cost of the commission (excluding postage) the remainder of your deposit will be refunded, after 14 days the full deposit will not be refunded. This charge is necessary due to the time spent and materials used in this time.

Completion and Delivery Times

Please indicate when ordering if you require your commission by a certain date. You will be advised before conformation if this date will be achievable, otherwise an approximate time of completion will be discussed. The time it takes from order conformation to completion, approval and payment clearing depends entirely on a number of factors, such as how much work is currently in progress and in the queue of work to be done, size, medium, number of subjects and detail required. For small Gouache paintings or pencil sketches the lead time will be approx. 3 weeks. This allows for approval by email and time for cheques to clear.

Copyright

By submitting an order form, either online or by post, you are agreeing that Gary Hall retains full copyright and licensing rights to the artwork produced, thereby allowing it to be used in anyway seen fit by the artist for an indefinite period of time. This includes displaying the artwork in advertising materials and online.

Photographs

By sending photograph(s) you are confirming that you own the copyright to the photographs or have gained permission and or licence from the copyright owner to grant Gary Hall licence to use the photograph(s), either by email or post you agree to indemnify me against any costs arising from claims made against me by persons claiming to own copyright.

Satisfaction Guarantee

Gary Hall guarantees all his artwork for quality and likeness to the chosen subject. If you are not completely satisfied with your commission on receiving it and it is returned safely wrapped and undamaged within 7 days you will receive a refund (minus deposit and postage costs). But this should not happen as you will be able to preview your completed commission by email for approval before it is dispatched.

Any artwork returned damaged and/or after 7 days will not be refunded.

By returning any artwork Gary retains it and the copyright and the right to display and/or sell it to a third party, or use the image in any way seen fit.
